I advised Detective VanWynsberg of the statements I got from both parties. While speaking with Detective VanWynsberg, Taylor exited the interview room and stated she wanted to leave. I advised Taylor that the detective was going to be with her momentarily. Taylor advised she was not willing to wait. I advised Taylor that she could have someone come pick her up from the lobby or that I could transport her back home. Taylor advised that she would like me to transport her home. I escorted Taylor to the lobby.

I returned to CID to gather my belongings and Detective VanWynsberg advised that he would like me to seize Taylor's phone prior to her leaving.

I returned to the lobby and asked Taylor who she was on the phone with, in which she replied [7(1)(c)]. I advised Taylor that we were going to seize her phone, so she needed to end her call. I advised Taylor that she was not under arrest, but her phone was going to be seized. I went to grab Taylor's phone and she pulled her phone away.

I advised Taylor that the fire is going to be under investigation and that her phone was going to be seized. Taylor continued to ask why and stated we were not taking her phone. Taylor switched to Facetime with [7(1)(c)] while I was speaking with her. Taylor asked if she could do the interview with the detective, so her phone won't be seized.

At this point Taylor was advised twice that if she did not hand me her cellphone, I was going to take the phone. Taylor continued to ask why her phone was being seized. I advised Taylor that if she wished to speak with a detective about her phone being seized, she was able to. Taylor went back and forth with me for several minutes and ultimately decided that she was not going to give an interview and not going to hand me her phone.

I walked towards Taylor and advised her to hand me her phone. Taylor turned around to prevent me from grabbing ahold of her phone. Taylor then kept her phone by her chest and dropped to the ground on her back in the fetal position with her knees to her chest. While on the ground Taylor stated she was not letting go of her phone. Taylor then kicked Officer McComber in the chest. See Officer McComber's supplemental report for more details. Taylor then kicked me in the head causing me to lose balance from the position I was in. Taylor then went to her stomach and placed her arms underneath her chest. Taylor was given several verbal commands to stop kicking and to release her arms from under her. Officers were able to get Taylor's arms behind her back and place handcuffs on her wrists. I checked the handcuffs for proper fit prior to having Taylor stand up. While on the ground Taylor continued to yell and pull away from Officers. Taylor was assisted to her feet.

Detective VanWynsberg asked Taylor if she was willing to speak with him in an interview room about the situation. Taylor continued to yell and stated she needed a lawyer.

I advised Taylor of why she was going to jail. Taylor stated, "I kicked you all because you all were manhandling me, I couldn't move; I was scared". Officer Kosenesky was able to double lock the handcuffs.

Taylor stated, "It wasn't aggravated assault it's called defending myself when I'm in harm's way". Taylor was searched incident to arrest

nothing of evidentiary value was located on her person.

I placed Taylor in the front seat of Officer McComber's squad car and secured her with a seatbelt.

I have attached my BWC video footage to this report.

The charge of Aggravated Battery of Peace Officer and Resisting will be cleared out with an adult arrest.

On 02/09/2023 at approximately 0357HRS I, Officer Yanor, was at the Normal Police Department in the roll call room. I began hearing a female scream in the front lobby. I heard Officer Cunningham yelling for someone to put their hands behind their back.

It should be noted, I am equipped with a Body Worn Camera (BWC) which I have reviewed. For clarity and brevity I have paraphrased and summarized the following incident. The items discussed may or may not be written in the order they appear on my BWC. The words I have chosen for this report may not be the exact words used by the involved parties.

I observed Officer Cunningham, Officer McComber, Officer Kosenesky, Officer Hines, and Sergeant Richmond struggling with Taylor A. Brown on the ground. Taylor was given multiple commands to put her hands behind her back. Taylor was on her stomach and kept both of her arms tucked under her after commands were given. I helped secure Taylor's legs. I then attempted to help get Taylor's hands behind her back. Taylor refused and kept her arms under her. We were able to get Taylor's hands behind her back and secure her in handcuffs.

I have attached my BWC and classified it as an arrest.

Taylor decided that she wanted to leave and not provide a statement. Taylor was escorted to the lobby to wait for a ride to take her home. I then asked Officer Kosenesky to watch Taylor while she was in the lobby. Taylor then inquired about the status of her ride. I asked her to give me moment. It should be noted I did not have BWC at this time. As I was walking back to CID, Officer Cunningham then informed me that Detective VanWynsberg wanted Taylor's phone seized. I gathered Officer Cunningham's property from CID and gathered my outer vest carrier and BWC. When I returned to the front desk officers were talking to Taylor about the phone. I gave Officer McComber my BWC since he did not have one. I acquired another BWC and asked Officer Searby to relieve Detective VanWynsberg in CID since there was another resident in an interview room. I asked Detective VanWynsberg to come to the lobby.

I entered the lobby and Taylor was refusing to turn over her phone. Officers Cunningham and Kosenesky attempted to grab the phone but she turned her body away. Taylor went to the ground and she began to flail her legs. Taylor was told to not kick and officers attempted to control her. While on her back, Taylor kicked her legs out again and I took control of her legs by pinning them to the ground. Officers continued to control Taylor until the phone was released and she was placed into custody. Detective VanWynsberg took possession of the phone. Taylor was taken to the main hallway of NPD and then transported to the McLean County Jail.

Metcom advised me [REDACTED] 7(1)(c): Third party name(s) and [REDACTED], called NPD. I called her back and advised her that I could not disclose information since [REDACTED] 7(1)(c): Third was an adult and she was taken to the McLean County Jail. She asked if she needed to call [REDACTED] 7(1)(c): Third. I informed her there was another female at NPD but was unaware who she was. [REDACTED] 7(1)(c): Third asked about court in the morning and she was advised to contact the courthouse. The call was then ended.

On 2/9/2023 around 0352 HRS, I, Officer McComber, began to assist Officer Cunningham after being advised Officers were seizing Taylor Brown's phone regarding **5 ILCS 140/7(1)(d)(i) :**

It should be noted that I was equipped with a Body Worn Camera (BWC). For clarity and brevity, I have paraphrased and summarized the following incident. The items discussed may or may not be written in the order they appear on my BWC. The words I have chosen for this report may not be the exact words used by the involved parties. I have watched portions of my BWC at this point.

After Officer Cunningham told Taylor that her phone was going to be seized, Officer Cunningham began walking towards Taylor. Taylor turned away from Officers and then curled into a ball going to the floor. Taylor began kicking her legs. As I held onto her legs, Taylor kicked me in my chest. Taylor was rolled onto her stomach. Taylor held both of her hands/arms under her body, preventing being placed into custody. She was ordered numerous times to release her hands. After Taylor continued to resist, I used my right thumb to apply pressure to her mandibular nerve and applied counter pressure with my left hand on Taylor's head. I told Taylor that I would continue to apply the pressure until she released her hands. Taylor was ordered multiple times, again, to release her hands. I immediately stopped applying pressure once Taylor released her hands.

After she was placed into custody, I transported Taylor with Officer Forman to the McLean County Jail.

NOTE: Once we arrived, she complained that the handcuffs were too tight (around 0428 HRS). I began to check the fit, and the jail staff was simultaneously coming to take custody of her. She was taken out of handcuffs by their staff.

I have attached my BWC to this report as evidence.

It should be noted, I am equipped with a Body Worn Camera (BWC) which I have reviewed. For clarity and brevity, I have paraphrased and summarized the following incident. The items discussed may or may not be written in the order they appear on my BWC. The words I have chosen for this report may not be the exact words used by the involved parties. My BWC has been added as evidence to the property section of this report.

SGT. Richmond notified me to watch Taylor, who was seated in the lobby, while Officer Cunningham was continuing with her investigation. Officer Cunningham then entered the lobby and told Taylor that her phone was going to be seized. Officer Cunningham began walking towards Taylor, at which point Taylor pulled her arms into her chest, grasping her phone. Taylor then turned away from officers and curled into a ball going to the floor. While on the floor, Taylor began kicking her legs which made contact with Officers McComber and Cunningham. Taylor was rolled onto her stomach, and I attempted to pull her left arm from under her chest. Taylor continued to hold both of her hands and arms under her body, preventing being placed into custody. Taylor was ordered multiple times to release her hands and place them behind her back. I was able to pull Taylor's left arm from under her body and placed a handcuff on her left wrist. Taylor's right arm was then pulled from under her chest and her right wrist was handcuffed as well.

After she was placed into custody, Officer McComber transported Taylor with Officer Forman to the McLean County Jail.

On Thursday, 02/09/2023 at approximately 0357 hours I was in the Normal Police Department roll call room. I heard a woman screaming in the Normal Police Department lobby. I went to investigate and observed officers attempting to control a female suspect, later identified as TAYLOR BROWN. I went to over to assist officers and held Taylor's right leg down. Officers were asking Taylor to put her hands behind her back. Taylor was not complying with commands. Officers were attempting to handcuff Taylor, so I let go of Taylor's right leg and went over to Taylor's left side. I pulled Taylor's left arm from under her body and placed it behind her back. Officers were then able to handcuff Taylor. After Taylor was handcuffed, I let go and backed away from Taylor.

I was not wearing my BWC at this time due to the fact my BWC was charging and uploading videos from earlier in the shift. Due to the nature of the offense, it would have taken too much time to retrieve my BWC and then assist officers. Sergeant Richmond advised me to retrieve my BWC from the docking station after the initial encounter, which I did. I then activated my BWC.

I uploaded my BWC to this report. I did not watch my BWC.
